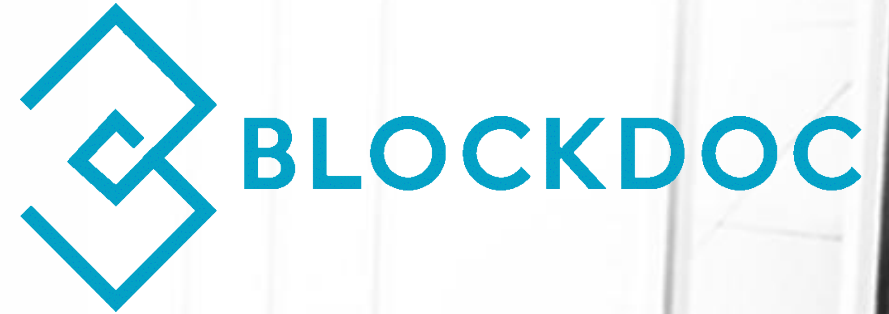
SSKN stands for Strategic Shared Knowledge Network
